REQUIRED DOCUMENT FOR PERMIT ISSUANCE

- Certificate of attestation confirming the business registration status in the Enterprise Register.
- Proof of civil and general liability insurance of at least \$2,000,000.
- Vehicle registration certificate for the vehicles used, registered under the company's name.
- Proof of insurance for each motor vehicle.
- A complete list of serviced clients (names and addresses).
- If the contractor is a legal entity, a copy of the certificate of incorporation.
- Written commitment to comply with all standards and provisions set forth in this By-law.

FEES RELATED TO PERMITS AND CERTIFICATES

Please refer to the applicable by-law for the current rates.

APPLICABLE REGULATIONS

Please ensure compliance with the regulations, including:

- **R-508** concerning snow removal
- **R-343-07** concerning parking, traffic and road safety.
Please note that parking is PROHIBITED AT ALL TIMES on Senneville Road.
- R-482 pertaining to nuisances, public health and security
- As well as the **Highway Safety Code** (CQLR, c. C-24.2) and its regulations.
