from 300 m <sup>2</sup> or more of a street or sidewalk	\$1.50 (cost/m <sup>2</sup> ) per day
<b>Width of the obstructed street</b>	
3 meters or less (1 lane)	\$52 per day
Between 3 and 6 meters (2 lanes)	\$104 per day
<b>Complete closure</b>	
Local street	\$104 per day
<b>Occupying a park or public space</b>	
When the surface area occupied is less than 50 m <sup>2</sup>	\$57 per day
